Re: Use of Electronic Circuit Court Case Information in SWIFT

Dear RMS Team:

As the Clerk of \_\_\_\_\_\_\_\_\_ (City/County), Virginia, Circuit Court, I hereby authorize the Office of the Executive Secretary ("OES") to make available the publicly available fields of the electronic case records contained in the Circuit Case Management System and viewable on the OES' Online Case Information System ("OCIS") to support the Virginia Criminal Sentencing Commission's ("VCSC's) Sentencing Worksheet & Interactive File Transfer system (SWIFT), which is designed to automate the creation of Sentencing Guidelines forms. I understand that case information may be integrated with and displayed to users of the SWIFT system and that use of and access to the SWIFT system will be limited to Commission staff, probation and parole officers, attorneys for the Commonwealth and their staff, and defense counsel. I understand that users of SWIFT will have access only to case information that is publicly viewable on OCIS, and that SWIFT will allow the Clerk to electronically submit Sentencing Guidelines forms and associated court orders to the VCSC in accordance with Virginia Code §19.2-298.01(E). I further understand that submission of these documents will be further automated for the Clerk if OES' Circuit Imaging System is utilized by the Clerk.

I understand that this authorization will remain in full force and effect until terminated in writing by letter to the OES RMS team signed by me or my successor.
