

Attempts and Conspiracies-Use VCC Code for actual crime and change "F" to "A" for attempts and "C" for conspiracies. For example, the offense "robbery-street" has a VCC of ROB-1214-F9 which would change to ROB-1214-A9 for an attempt and ROB-1214-C9 for a conspiracy to commit this specific crime.
