From Bristol, Tennessee and west:


Take Interstate 81 north to Exit 14. Bear right off the ramp toward Abingdon. Go ¼ mile and turn right into the College.

From Wytheville, Virginia and east:

Take Interstate 81 south to Exit 14. Bear right off the ramp toward Abingdon. Go ¼ mile and turn right into the College.

From Bluefield, West Virginia, and north:

Take Highway 19 south to the stoplight at West Main Street (Highway 11). Bear right. Go 1 mile to the second stoplight and turn left. The College will be on your left.

GENERAL INFORMATION

The Virginia Criminal Sentencing Commission is pleased that you will be attending the *What's New 2004* seminar at the **Southwest Virginia Higher Education Center** in Abingdon. Below you will find some general information about what to expect from your training experience.

Course Design

All Sentencing Guidelines Training classes are based on one fundamental educational principle: "Students learn by doing." With this approach to learning, much of the course involves active student participation in individual and group exercises. The course instructors will lecture on various topics, and then, students will be given an opportunity to do hands-on exercises, utilizing the assistance of fellow classmates and course instructors.

Breaks, Food, Dress Code

Dress is casual. Light snacks and beverages will be offered, and a break will be taken during the class.

One-on-One Assistance

Course leaders will be available during the break and after class to discuss any questions you may have concerning cases on which you are working. Also, course leaders and other Commission staff are available to answer your questions by contacting the Commission's hotline at (804) 225-4398 during normal business hours Monday through Friday. In addition, if you do not understand something, the course leaders encourage you to ask questions at any time during the class.

Course Materials

During the training class, a bound copy of "Structured Notes" will be provided to you. Updates to the Guidelines Manual will be sent via UPS to all state employees (e.g., probation officers, Commonwealth attorneys, and public defenders). If you are a non-state employee, and you have submitted an order form with payment, your manual/update will be shipped via UPS. Please contact the Commission at (804) 225-4398 to request an order form, or you may download a copy from the Commission's website at www.vcsc.state.va.us/training. If you would like, you may bring your own copy of the Guidelines Manual to class, but it is not required.
